Am I a desirable applicant?

- ☐ I am a citizen of PNG and I reside in PNG
- ☐ I have at least two years' work experience in my employment sector
- ☐ I work in one of the priority sectors:
 - agriculture
 - education
 - governance
 - health
 - law and justice
 - transport and infrastructure
- ☐ I am applying for a progressive tertiary qualification (i.e. a masters degree if I already have a bachelor's degree; another masters in a different subject area or field of specialisation if I already have a masters from a PNG institution)
- ☐ I am committed to returning to PNG
- ☐ I am able to meet the Australian visa requirements (subclass 500)
- ☐ I am not applying for a visa to live in Australia and I am not in a relationship with an Australian citizen or permanent resident.

Level of study

Awards will be offered for commencement in 2025 in the following level of study:

- ☐ Masters by Coursework - majority of awards will be offered at the masters-level qualification to extend technical expertise across the priority sectors.
- ☐ Undergraduate - a limited number of undergraduate awards will be offered for bachelor's degree programs not available in PNG and contributes to a priority sector and/or for people living with a disability.
- ☐ PhD and Masters by Research - a limited number of research awards will be offered to academic and research staff of tertiary and research institutions in PNG to strengthen teaching and research in these institutions.

If the applicant meets the eligibility criteria, the scholarship team will contact the applicant for a consultation session in February or March 2024.

All Intake 2025 applications must be submitted online using the Online Australia Awards Scholarships Information System (OASIS) <https://oasis.dfat.gov.au/>. Applications by email **will not be accepted**.

Priority sectors and study topics



Intake 2025 priority sectors and study topics

Australia Awards Scholarships Intake 2025 will prioritise six sectors and a range of study topics within each sector. The priority sectors and study topics are drawn from the priorities of the PNG-Australia Partnership.

Agriculture

Agribusiness; agricultural economics; aquaculture and marine studies; biosecurity; climate change studies; conservation sciences; fisheries; food security; forestry; horticulture; plant science and technology; soil science; supply chain management (including supply chain innovation and logistics studies); sustainable agriculture, veterinary science.

Education

Clinical education; climate change studies; dietetics and nutrition (for schools); digital learning; education; education leadership; exercise and sports science; health education; health promotion for schools; human movement (sports teaching); mathematics teaching; nutrition and population health (for schools); outdoor and environmental education; reading and literacy; science teaching; secondary education; special and inclusive education; sports education; sustainable development; teaching practice; technology (for teaching).

Health

Eligibility



Eligibility criteria

To be eligible to receive an Australia Awards Scholarship, applicants must:

- be a minimum of 18 years of age at the time of commencing the scholarship
- be a citizen of PNG and be residing in and applying for the scholarship from PNG
- not be married, engaged or a de facto of a person who holds, or is eligible to hold, Australian or New Zealand citizenship or permanent residency, at any time during the application, selection or mobilisation phases of the scholarship
- not be currently serving military personnel
- not be a citizen of Australia, hold permanent residency in Australia or be applying for a visa to live in Australia permanently
- not have previously received a long-term Australia Award in the previous four years
- have satisfied the following criteria:
 1. hold at least two years' work experience in their sector
 2. work in one of the priority sectors (agriculture, education, governance, health, law and justice, or transport and infrastructure)
 3. be applying for a progressive tertiary qualification
 4. be able to satisfy the admission requirements of the institution at which the award is to be undertaken
 5. be able to satisfy all requirements of the Australian Department of Home Affairs to hold a Student Visa
 6. not hold convictions of criminal activities (including in their home country) including those relating to "Child Protection and PSEAH."

Applicants must use AAPNG form for reintegration plan, referee reports and CV; all forms can be downloaded from www.australiaawardspng.org.

Public servant applicants must also submit duly completed Bid Form (signed and stamped by Chairman, Training Committee/Agency Head) and supporting documents to the Department of Personnel Management.

Applications without the required documentation will be deemed non-compliant.

Public category

Employees of public category organisations listed below are considered **public category applicants**. Applicants under this category must check with their human resource manager or SD&T officer if they are listed in their organisation's Learning and Development Plan and are therefore eligible to be nominated for overseas training. For further questions regarding these requirements, please contact the **Department of Personnel Management** on **3276382/358** before applying. Public servants are not allowed to apply under the open category.

Temporary contractors of public sector universities and research institutions are not considered public category applicants and should state this on their application.

Frequently asked questions

FAQs: Preparing an application

How do I certify my academic documents?

You must provide certified copies of your prior academic certificates and transcripts as part of your scholarship application.

Copies of your academic certificates and transcripts must be certified by a **PNG Commissioner of Oath**.

- You must ask the Commissioner of Oath to **sign, stamp** and **date** your copies
- The date of the certification must be 1 January 2023 later.
- Commissioner of Oath stamping can be requested at the court house and from registered lawyers. Typically there is no fee for this service

Please note: copies of academic certificates and transcripts submitted without Commissioner of Oath certification cannot be assessed as part of your application and your application will be non-compliant.

Are my course preferences important?

You must nominate two course preferences on your scholarship application. Your two course preferences are very important, because:

- your suitability for the scholarship will be assessed based on your application responses about your nominated two courses
- the selection panel are interested in understanding what you want to study and why you chose that topic
- course changes will not be possible after you submit your scholarship application, so you must be confident that the two course preferences you nominate on your application are the appropriate choices.

You are responsible for fully researching and investigating course options prior to submitting your application.

Remember to check that you meet the institution's entry requirements for the courses you nominate.

When I nominate two course preferences, do I get to study both courses?

If you are successful, you will only study one course preference. Australia Awards will attempt to enrol you in your first course preference. If the institution is not able to accept your enrolment, then Australia Awards will attempt to enrol you in your second course preference. The second course preference is a back-up option.

What course information do I need to provide on my application?

You need to ensure the course name, institution name and CRICOS reference code for your two course preferences are recorded on your application.

What is a reintegration plan?

The reintegration plan outlines how you will apply the knowledge and skills you will acquire in Australia towards the development of PNG. You must be able to demonstrate understanding of development needs in your sector, organisation, community or PNG and identify how your new qualification will contribute towards these needs.

Your reintegration plan will help the selection panel assess your potential to contribute to and lead development in PNG on your return from Australia.

In preparing for your reintegration plan, you should consult the PNG Medium Term Development Plan IV (available at <http://www.planning.gov.pg>)

I already have a master's degree. Can I apply for an Australia Awards Scholarship to study a second master's?

Yes, if you obtained your master's degree from a PNG institution. However, the proposed second masters must be in a different field or area of specialisation.

No, if you obtained your master's from an institution overseas. This is to provide equal opportunity for all PNG citizens to study overseas.



How do I find courses and CRICOS codes?

CRICOS stands for Commonwealth Register of Institutions and Courses for Overseas Students.

We recommend you first visit the CRICOS website:

- type **<http://cricos.education.gov.au>** into your internet browser
- click on Course Search
- adjust the search criteria to explore available courses. For example, type your topic into the Course Name field, or search for a particular field of study
- the search will provide a list of courses that meet your search criteria
- click on one of the course options
- it will display the Institution Name, Course Name, CRICOS Course Code, and other information
- write down the courses you are interested in.

We recommend you then visit the relevant university websites and undertake thorough research on the courses you are interested in studying. We suggest you consider:

- the duration of the course
- the entry requirements stated on the university website
- the course structure and any course specialisations
- click on the individual subjects to see what is included in each aspect of the course

- the relevance of the content of the individual subjects to your work in PNG
- the impact this course could have on expanding your knowledge and skills
- the academic staff that teach the course – consider the key people and their specialisations
- the reputation of the institution within your sector. For example, if you work in agriculture, consider if the university has a strong reputation in the agriculture sector.

Once you have a list of courses that meet your knowledge and skill development needs, consider speaking to people in your network—explore what they know about the courses and institutions you are considering.

If you have questions about the course, email the institution directly and ask questions. Remember to allow sufficient time for the institution to respond.

Do I need an offer letter from the university?

No, you do not need an offer letter for your scholarship application. Australia Awards will help you enrol in the institution if you are successful in being awarded the scholarship.

Do I need an English test result for my application?

No, this is not a mandatory question. If you do not have an English test result, select 'None' in this section of the application.

Can I apply now and send the required support documents for my application at a later date?

In the interest of fairness for all applicants, only compliant and complete applications will be assessed. If you choose not to provide the required documents, your application will be recorded as noncompliant in the system. Only compliant applications will progress to the assessment stage.

I am a public servant. Can I provide a Statement of Support from my supervisor, instead of following the Training Bid process?

All applicants must provide a professional referee report. Government of PNG employees must also submit an approved Training Bid Form to the Department of Personnel Management.



FAQs: Submitting an application

How do I submit my application?

OASIS application tips:

- You must register for your own unique OASIS log-in and password.
- Do not submit your application using another person's log-in and password.
- We recommend using a non-work email address, such as Gmail or Hotmail. Work emails may have firewalls that block outside addresses and at times can be offline.
- Consider using a reliable email account for your scholarship application.
- It is recommended OASIS be accessed using Google Chrome or Firefox browsers.
- You do not need to start, finish and submit your application all at once. You can complete your application over a period of time and save it as you go.
- Each page will begin with Help Text, which explains how to complete the application page.

- If you do not complete the mandatory fields on the application page, an error message will appear in red.
- The answer boxes on each application page have character limits. Characters are letters, spaces and punctuation marks. If you exceed the character limit, an error will appear and your response might not save until you reduce the number of characters.
- A checklist is shown in OASIS on the left hand side of the webpage. A tick symbol indicates that the application section has been completed. The (x) symbol indicates the section is incomplete.
- All attachments must be 2MB or less.

OASIS registration steps:

1. Type <https://oasis.dfat.gov.au> into your Google Chrome, Safari or Firefox browser
2. Click [Logon / Register](#)
3. Click on [Register New Account](#)
4. Register with your email, name (as per ID document/passport), date of birth and contact number
5. A temporary password will then be sent to your email address
6. Log-in with the temporary password provided and follow the instructions to set a new password
7. You now have access to the application system.

Helpful tip

An asterisk (*) symbol is shown next to mandatory questions, which you must complete. If you leave a mandatory question blank, the system will not let you submit your application.

You must complete all mandatory questions.

What are the next steps after applications close?

Mandatory Pre-departure Training for Intake 2025 candidates

Intake 2025 awardees travel to Australia (dates vary depending on course start dates)



About assessments, tests and interviews

Shortlisted candidates will be contacted and invited to panel interview and tests.

Logistical arrangements will be provided by Australia Awards PNG for candidates who reside outside Port Moresby.

The International English Language Test System (IELTS) is a test for your English language listening, reading, writing and speaking skills. Most Australian universities have a minimum IELTS score required for entry to their courses.

The Australia Awards office will organise and register for your IELTS test. Due to the timeline for the assessment and selection process, you will be notified about the tests approximately two weeks before the test dates.

You must bring your NID card or your current passport or driver's licence plus birth certificate, to the test on the day. If you do not have your ID, you will not be able to sit the test and you will be removed from the scholarship shortlist.

We recommend you consider preparing for tests in advance, so that you are adequately prepared in the event that you are invited to sit the tests. Free online practice tests and guides for IELTS are available through:

All undergraduate and masters by coursework applicants also take an hour and two-page essay test on leadership and development in PNG to measure their skills in academic writing and understanding of their roles as change leaders in the country.

FAQs: On-scholarship

Who arranges my visa?

Australia Awards will support the awardee in arranging their student visa. Awardees are responsible for arranging their dependants' visas.

Can I bring my children with me to Australia while I undertake the scholarship?

Awardees' dependants (including spouse and children) may be able to accompany them to Australia. Awardees are responsible for arranging their dependants' visas to go to Australia. Awardees must meet the requirements for their dependants, including demonstrating sufficient funds.

Can my children attend school in Australia?

Australia is well known for its quality education system and offer a range of different education options. For more information on Australia's education system visit www.studyinaustralia.gov.au.

Is there an age limit for applying for an Australia Awards Scholarship?

There are no formal age limits, however Australia Awards aim to identify individuals that upon completion of their scholarship will return to Papua New Guinea and contribute to the country's development (both professionally and within the community).





If I am successful in my scholarship application and I become pregnant will my scholarship be terminated?

Pregnant applicants are encouraged to share this information with Australia Awards PNG at their earliest opportunity, so planning can be undertaken about the best time to commence studies. Awardees will be assessed equally. Pregnant applicants will not be disadvantaged.

What assistance will be available to me during my stay in Australia?

All universities in Australia have student service centres that provide guidance and emergency support to students during their stay in Australia. The student service centres can help students in arranging accommodation, accessing family support and to meet, to the extent possible, any special needs of the students. Australian universities also have health and counselling services that are free or discounted for students, as well as a range of sporting, shopping and other facilities on campus. In addition, Australia Awards PNG provide on-scholarship support to awardees in Australia.

Can I work part-time while studying in Australia?

Currently Australia Awards recipients are permitted to work part-time (up to 20 hours a week) under the conditions of the subclass 500 student visa. It is important you inform your Student Contact Officer to ensure it does not affect your academic progress.

Can my spouse work while accompanying me on my scholarship?

Please refer to the Australian Department of Home Affairs for information about the conditions of your dependents visa.

Can I apply for a scholarship for Intake 2025 if I applied in the past and I was unsuccessful?

There is no limit to how many years an applicant can apply for an Australia Awards Scholarship. Applicants are assessed based on their current application, and their past applications will not be reassessed.

Can people with disability apply for a scholarship?

People with disabilities are encouraged to apply for a scholarship. People will not be disadvantaged by declaring their disability. Reasonable adjustments and accommodations will be made to remove barriers for people with disabilities.

However, all applicants must meet the eligibility requirements for the scholarship and submit a compliant application.

If you have a disability, please contact the Australia Awards office to request a copy of the Factsheet for People with Disability. This contains detailed information about support available.

Important message

Family and sexual violence is a criminal offence in Australia. All criminal offences, including family and sexual violence, are treated very seriously by the Australian Government.

The Australian Government also takes a zero-tolerance approach to fraud. All application documents will be verified against the applicant's identity. Fraudulent applicants will be excluded from consideration for the relevant scholarship and any future Australia Awards.
